

# **Rights & Responsibilities:**

## **The Rights of Requesters and the Responsibilities of the Middlesex County Treasurer under the Virginia Freedom of Information Act**

The Virginia Freedom of Information Act (FOIA), located in § 2.2-3700 et seq. of the Code of Virginia, guarantees citizens of the Commonwealth and representatives of the media access to public records held by public bodies, public officials, and public employees.

A public record is any writing or recording—regardless of whether it is a paper record, an electronic file, an audio or video recording, or any other format—that is prepared or owned by, or in the possession of a public body or its officers, employees, or agents in the transaction of public business. All public records are presumed to be open, and may only be withheld if a specific, statutory exemption applies.

The policy of FOIA states that the purpose of FOIA is to promote an increased awareness by all persons of governmental activities. In furthering this policy, FOIA requires that the law be interpreted liberally, in favor of access, and that any exemption allowing public records to be withheld must be interpreted narrowly.

### **Your FOIA Rights**

- You have the right to request to inspect **or** receive copies of public records, or both.
- You have the right to request that any charges for the requested records be estimated in advance. As of July 1, 2022, public bodies must notify the requester in writing that the public body may make reasonable charges not to exceed its actual cost incurred in accessing, duplicating, supplying, or searching for requested records and inquire of the requester whether he would like to request a cost estimate in advance of the supplying of the requested records.
- If you believe that your FOIA rights have been violated, you may file a petition in district or circuit court to compel compliance with FOIA. Alternatively, you may contact the FOIA Council for a nonbinding advisory opinion.

### **Making a Request for Records from the Middlesex County Treasurer**

- You may request records by U.S. Mail, fax, email, in person, or over the phone - FOIA does not require that you use any particular method to convey your request. FOIA also does not require that your request be in writing, nor do you need to state that you are requesting records pursuant to FOIA.

- From a practical perspective, it may be helpful to both you and the person receiving your request to put your request in writing. This allows you to create a record of your request. It also gives us a clear statement of what records you are requesting, so that there is no misunderstanding over a verbal request. However, we cannot refuse to respond to your FOIA request if you elect to not put it in writing.
- Your request must identify the records you are seeking with "reasonable specificity." This is a common-sense standard. It does not refer to or limit the volume or number of records that you are requesting; instead, it requires that you be specific enough so that we can identify and locate the records that you are seeking.
- Your request must ask for existing records or documents. FOIA gives you a right to inspect or copy **records**; it does not apply to a situation where you are asking general questions about the work of the Middlesex County Treasurer's Office, nor does it require the Treasurer's Office to create a record that does not exist.
- You may choose to receive electronic records in any format used by the Middlesex County Treasurer's Office in the regular course of business.
  - For example, if you are requesting records maintained in an Excel database, you may elect to receive those records electronically, via email, on a computer disk or flash drive, or to receive a printed copy of those records.
- If we have questions about your request, please cooperate with staff's efforts to clarify the type of records that you are seeking, or to attempt to reach a reasonable agreement about a response to a large request. Making a FOIA request is not an adversarial process, but we may need to discuss your request with you to ensure that we understand what records you are seeking.

In addition, the Freedom of Information Advisory Council is available to answer any questions you may have about how FOIA works. The Council was created in the legislative branch of state government to issue opinions on the operation and application of FOIA, to publish educational materials, and to provide training about FOIA. However, please be aware that the Council is not a records repository and does not process records requests on behalf of other public bodies, nor is the Council an investigative or enforcement agency. Pursuant to [Virginia Code Section 2.2-3704.1\(B\)](#), we have provided the FOIA Council's [Public Comment Form](#). Any requestor may make a public comment on the quality of assistance provided by the public body.

## **Middlesex County Treasurer's Responsibilities in Responding to Your Request**

- The Middlesex County Treasurer must respond to your request within five working days of receiving it. "Day One" is considered the day after your request is received. The five-day period does not include weekends, holidays, or other days when the Middlesex County Treasurer's Office is closed for business.
- The reason behind your request for public records from the Middlesex County Treasurer is irrelevant, and you do not have to state why you want the records before we respond to your request. FOIA does, however, allow the Middlesex County Treasurer to require you to provide your name and legal address.
- FOIA requires that the Middlesex County Treasurer make one of the following responses to your request within the five-day time period:
  - 1) We provide you with the records that you have requested in their entirety.
  - 2) We withhold all of the records that you have requested, because all of the records are subject to a specific statutory exemption. If all of the records are being withheld, we must send you a response in writing. That writing must identify the volume and subject matter of the records being withheld, and state the specific section of the Code of Virginia that allows us to withhold the records.
  - 3) We provide some of the records that you have requested, but withhold other records. We cannot withhold an entire record if only a portion of it is subject to an exemption. In that instance, we may redact the portion of the record that may be withheld, and must provide you with the remainder of the record. We must provide you with a written response stating the specific section of the Code of Virginia that allows portions of the requested records to be withheld.
  - 4) We inform you in writing that the requested records cannot be found or do not exist (we do not have the records you requested). However, if we know that another public body has the requested records, we must include contact information for the other public body in our response to you.

- 5) If it is practically impossible for the Middlesex County Treasurer to respond to your request within the five-day period, we must state this in writing, explaining the conditions that make the response impossible. This will allow us an additional seven working days to respond to your request, giving us a total of 12 working days to respond to your request. In the case of criminal investigative files requested pursuant to § 2.2-3706.1 of the Code of Virginia, we are allowed an additional 60 working days to respond to your request, giving us a total of 65 working days to respond to your request.
- If you make a request for a very large number of records, and we feel that we cannot provide the records to you within 12 working days without disrupting our other organizational responsibilities, we may petition the court for additional time to respond to your request. However, FOIA requires that we make a reasonable effort to reach an agreement with you concerning the production of the records before we go to court to ask for more time.

## **Charges**

- A public body may make reasonable charges not to exceed its actual cost incurred in accessing, duplicating, supplying, or searching for the requested records. No public body shall impose any extraneous, intermediary, or surplus fees or expenses to recoup the general costs associated with creating or maintaining records or transacting the general business of the public body. Any duplicating fee charged by a public body shall not exceed the actual cost of duplication. Prior to conducting a search for records, the public body shall notify the requester in writing that the public body may make reasonable charges not to exceed its actual cost incurred in accessing, duplicating, supplying, or searching for requested records and inquire of the requester whether he would like to request a cost estimate in advance of the supplying of the requested records as set forth in [subsection F of § 2.2-3704 of the Code of Virginia](#).
- Staff Time: Depending on the time involved, hourly staff charges may be assessed.
- Copying Costs: \$0.25 per copy for 8.5" x 11" and 8.5" x 14"  
\$0.50 per copy for 11" x 17"  
(first 3 copies are complimentary for all sizes above)  
\$10.00 per thumb drive (price does not include staff time - staff time will be calculated separately)
- Overhead costs will not be included.
- You may have to pay for the records that you request from the Middlesex County Treasurer's Office. FOIA allows us to charge for the actual costs of responding to FOIA requests. This would include items like staff time spent searching for the

requested records, copying costs, or any other costs directly related to supplying the requested records. General overhead costs will not be included in the charges.

- You may request that we estimate in advance the charges for supplying the records that you have requested. This will allow you to know about any costs upfront or give you the opportunity to modify your request in an attempt to lower the estimated costs. The five days that we have to respond to your request does not include the time between when we send you the estimate and when you respond. If you do not respond within 30 days, then your request will be deemed to be withdrawn.
- If we estimate that it will cost more than \$200 to respond to your request, we may require you to pay a deposit, not to exceed the amount of the estimate, before proceeding with your request. The five days that we have to respond to your request does not include the time between when we ask for a deposit and when you respond.
- If you owe us money from a previous FOIA request that has remained unpaid for more than 30 days, the Middlesex County Treasurer may require payment of the past-due amount before she will respond to your new FOIA request.

## **Types of Records**

The following is a general description of the types of records held by the Middlesex County Treasurer:

- Personnel records concerning employees and officials of the Middlesex County Treasurer's Office
- Records of contracts which the Middlesex County Treasurer has entered into
- All other records commonly kept by the Middlesex County Treasurer

## **Commonly Used Exemptions**

The Code of Virginia allows any public body to withhold certain records from public disclosure. The Middlesex County Treasurer commonly withholds records subject to the following exemptions:

- Personnel records (§ 2.2-3705.1 (1) of the Code of Virginia)

- Records subject to attorney-client privilege (§ 2.2-3705.1 (2)) or attorney work product (§ 2.2-3705.1 (3))
- Vendor proprietary information (§ 2.2-3705.1 (6))
- Records relating to the negotiation and award of a contract, prior to a contract being awarded (§ 2.2-3705.1 (12))

### **Policy Regarding the Use of Exemptions**

Records may be withheld entirely or in part because their release is prohibited by other laws or because the Middlesex County Treasurer has exercised her discretion to withhold exempt records in accordance with FOIA. When records are withheld, the Treasurer's response will be in writing within five (5) workdays of the original request. The response shall identify with reasonable specificity the volume and subject matter of withheld records and cite, as to each category of withheld records, the specific code section that authorizes the withholding of the records. Public records requests submitted to the Treasurer become public records and therefore are subject to disclosure under FOIA unless an exemption applies. In addition to FOIA, certain state and federal laws outside of FOIA prohibit disclosure of specific types of records and specific types of information contained in records maintained by the Treasurer.
